d Full day, year round? **Places could be made available full day, year round at Social Work Centres dependant on need.**

e Extended hours / wrap around, term time only (ie: 8am to 6pm with parents paying for wrap around hours)? **Not available in Council Nurseries. Children placed at childminders could purchase any additional hours (subject to availability) year round. Places at Scottish Childminders Association are made available as required.**

f Extended hours / wrap around, year round? **Council Wraparound is not currently registered for 2 year olds.**

g Are there any other models of provision offered in council nurseries? **No.**

6 In the final term of 2015/16, how many council nursery places for 3 ; 5 year olds were made available as

a Half day, term time only? **4900 physical places available in Council establishments, all of which could be configured as half day if required.**

b Half day, year round? **Wraparound is made available in the holidays with places made available dependant on demand.**

c Full day, term time only (ie: two free half day sessions in the same day plus lunch)? **144 places were specifically made available as two full day provision. This number could be varied dependant on demand.**

d Full day, year round? **Wraparound is made available in term time at some establishments, with number of places made available dependant on hours requested, and in the holidays with places made available dependant on demand.**

e Extended hours / wrap around, term time only (ie: 8am to 6pm with parents paying for wrap around hours)? **144 places were specifically made available as two full day**

provision, with wraparound available for purchase. This number could be varied dependant on demand.

f Extended hours / wrap around, year round? 144 places were specifically made available as two full day provision, with wraparound available for purchase. This number could be varied dependant on demand. Wraparound is made available in the holidays with places made available dependant on demand.
